We are expecting a diverse range of floats and encourage your unique talent in creating a one-of-a-kind entry!

Parade of Lights entries will still compete for six distinguished awards, judged by a panel of community leaders. Winners will receive a trophy commemorating the achievement plus recognition from the local media and community.

There will be six awards given out following the parade. Judging will take place throughout the event. You will be sent an information packet with a number assigned to your float. There will be two copies: one for the left side of the float and one for the right side so judges and the public can easily identify your float. The number is only for the judges use - not the order in which the floats are lined up. More information on this will be sent with the information packet in November.

Judging Categories

- First Banks & Trust Hometown Pride Award:
 This award will be given to the float that best represents hometown pride, no matter what community you are from!
- Best Use of Lights: This award is given to the float that shows the most ingenuity and engineering in light usage and special effects for visual appeal.
- Spirit of Sioux Falls: This award is for the float exhibiting the most public appeal, charm, and most creatively pleasing the crowd. This award will be chosen by the public.

- Mayor's Choice: This award is given to the personal favorite of Sioux Falls Mayor Paul TenHaken (pending availability).
- Downtown Sioux Falls Award: This award goes to the favorite of the DTSF Board of Directors.
- Best Workmanship: This award is given to the float that displays outstanding craftsmanship, neatness, attention to detail, overall design and usage of color and materials.



- 1. All entry registration forms and preliminary descriptions and dimensions of float must be received by Downtown Sioux Falls, Inc. (DTSF) by Monday, November 2, 2020, at 5:00pm.
- 2. A non-refundable entry fee of \$30 must accompany the registration form. There is no participation cost for Downtown Sioux Falls, Inc. members. Registration applications received after November 2, 2020, may or may not be considered for entrance and will incur a \$100 late fee.
- 3. There will <u>not</u> be a specific theme this year, but all of the holiday and festive decorations and lights are encouraged throughout your display!
- 4. A maximum of 60 entries will be accepted.
- 5. The exact event start & end times have not be solidified, but plan for the event to be at least 2 hours.
- 6. It is strongly encouraged that your float has an attendant present throughout the event. An option is to rotate that attendant throughout the event if necessary. All floats must have an attendant present at least a half an hour before the end time in order to re-open the streets.
- 7. No entry may include a live Santa Claus. Mrs. Claus, reindeer and elves are fine.
- 8. Participants are responsible for ensuring that all copyright permissions are sought and obtained in the event that they are using characters subject to such protection. Event organizers do not provide such consent and comply with all applicable laws governing copyright protection.
- 9. <u>All entries must be well lit</u> for evening viewing, using white and/or colored lights.
- 10. Because the floats will be stationary this year, music (live or recorded) is not required, but welcome. The music should be a festive holiday selection. Please mark below if your float features music.
- 11. The total dimensions of the float cannot exceed the following measurements:



Unit dimensions depend on your display; however, entry requests smaller than 40 square feet require special approval. No large semis, tractors, buses, motor homes, campers or RVs.

Rules of Participation Continued

- 12. All entries must be self-propelled or motor vehicle pulled. Tow-vehicles must feature lights and be incorporated into the overall theme and design of the entry. Walking units must also be lit. No horses are allowed.
- 13. Every float and towing apparatus is encouraged to carry a fire extinguisher readily accessible to the operator.
- 14. Generators or batteries may be used to power lights and/or sound equipment the energy source must be large enough to safely provide adequate power. Be sure to test your light display before the parade to ensure you have an adequate power supply. All entries using generators should attempt to muffle the generator noise so it does not drown out the music.
- 15. For the safety of spectators, **no items may be tossed from your float during the parade**. This rule is a City of Sioux Falls Ordinance, and violation may result in a ticket and fine. No crowd members may approach the float.
- 16. Candy and balloons are <u>not allowed</u> to be distributed along the parade route. § 96.190 DISTRIBUTION AT PARADES. No person conducting, managing or participating in any parade shall distribute or permit the distribution of any candy or balloons to persons in attendance during the parade.
- 17. No confetti cannons.
- 18. No alcohol is to be consumed in the staging area or along the parade route.
- 19. Company logos cannot be the main focus or theme of the float. However, the entry sponsor's name should be prominently displayed on the sides or rear of the parade unit. Every entry should have a holiday theme.
- 20. No political campaigning activities are permitted in or during the parade. Downtown Sioux Falls, Inc. is a non-profit and as such does not endorse any political candidate, political party or political issue. Existing officeholders are invited to march in the parade to represent the office that they hold, but cannot promote themselves as candidates as part of that or any other unit. Candidates for public office who are not currently officeholders can participate in the parade but cannot be the focus, in part or in whole, of any unit. No political information of any kind may be handed out, promoted or displayed as part of any unit including political signs or shirts, political campaign advertising, literature, balloons, stickers, posters, hand-outs, flyers or billboards.
- 21. *NOTE THIS IS A CHANGE* We will be communicating leading up to the event regarding line up procedure please check emails frequently and allow communication from DTSF in your inbox.
- 22. No vehicles, except registered vehicles, will be allowed to enter the staging area at any time. All public parking ramps and lots will be open for personal vehicle use. Information on staging and the parade route will be emailed to accepted entrants at a later date.
- 23. Entries that do not meet parade standards will not be allowed in the parade. DTSF reserves the right to remove any entry from the parade at any time for any reason.
